Here is a calculator example:


• € 100,000 profit - € 24,500 trade allowance = € 75,500 trade income
€ 75,500 x 25% = € 18,875 trade tax


• € 7,500 AG x 4% (491% tax rate !!!) = € 300 AG trade tax payable
€ 2,292.50 x 24% (24.03% lifting rate !!!) = € 550.20 trade tax AG corporate
