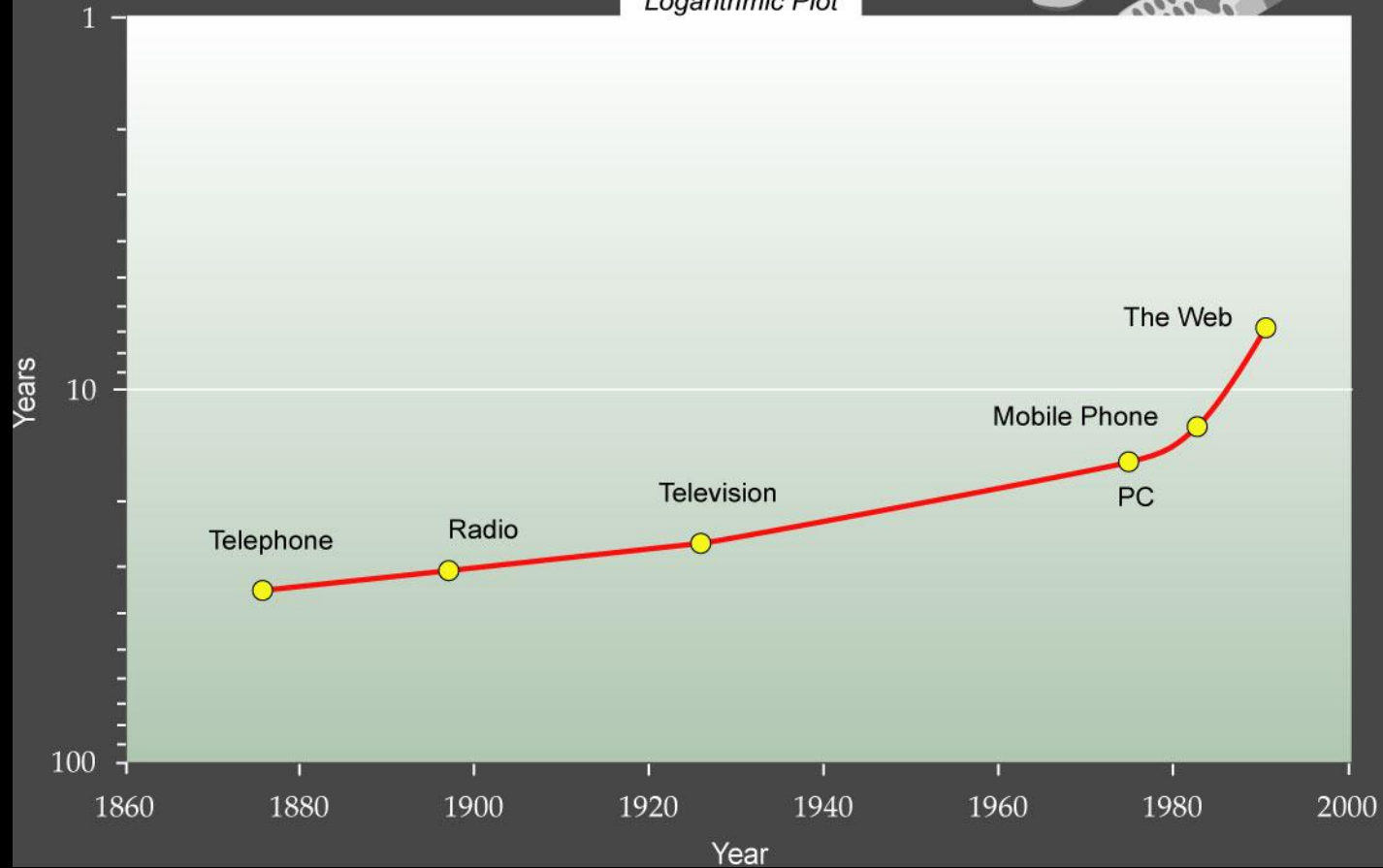


## Mass Use of Inventions

Logarithmic Plot



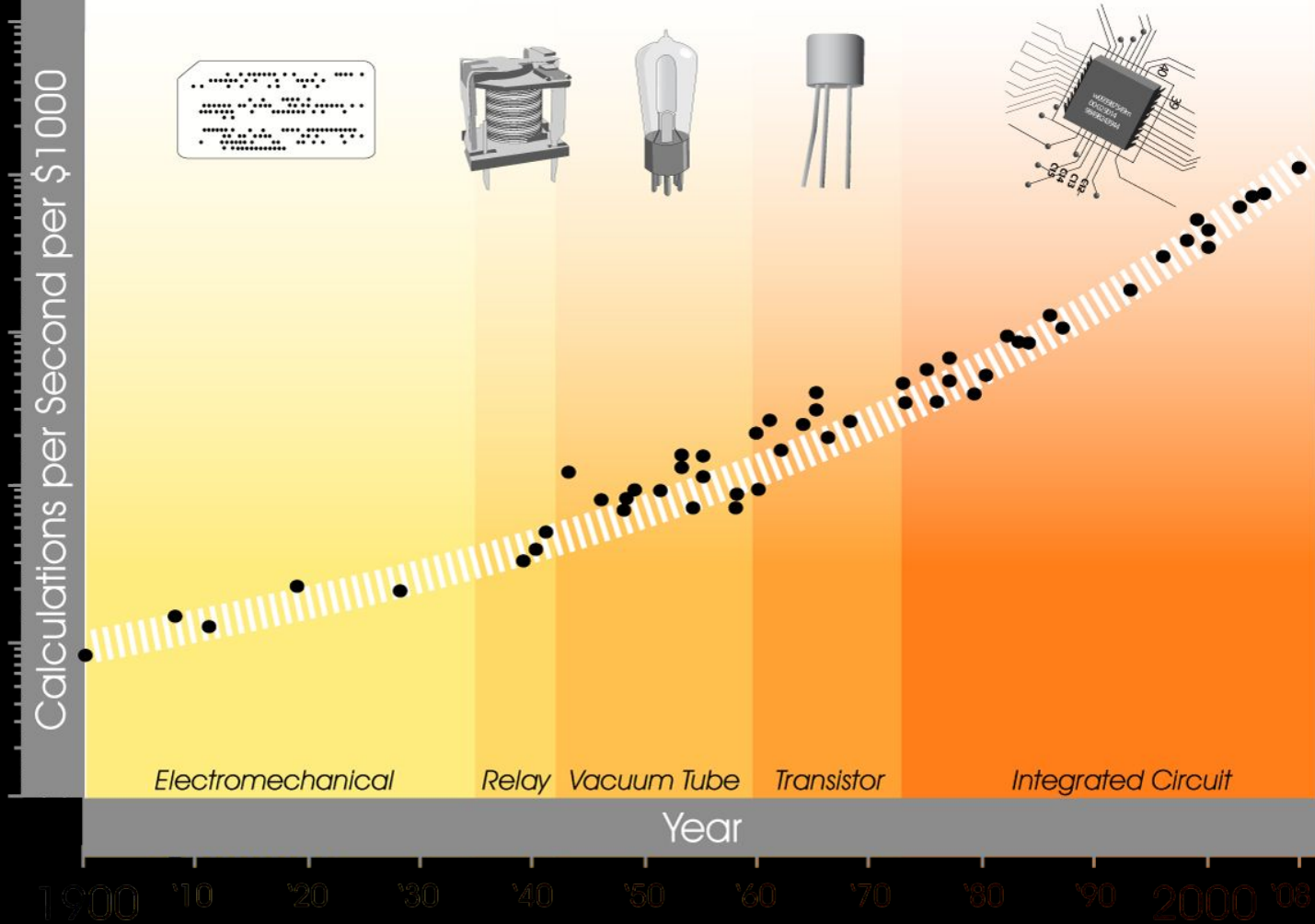

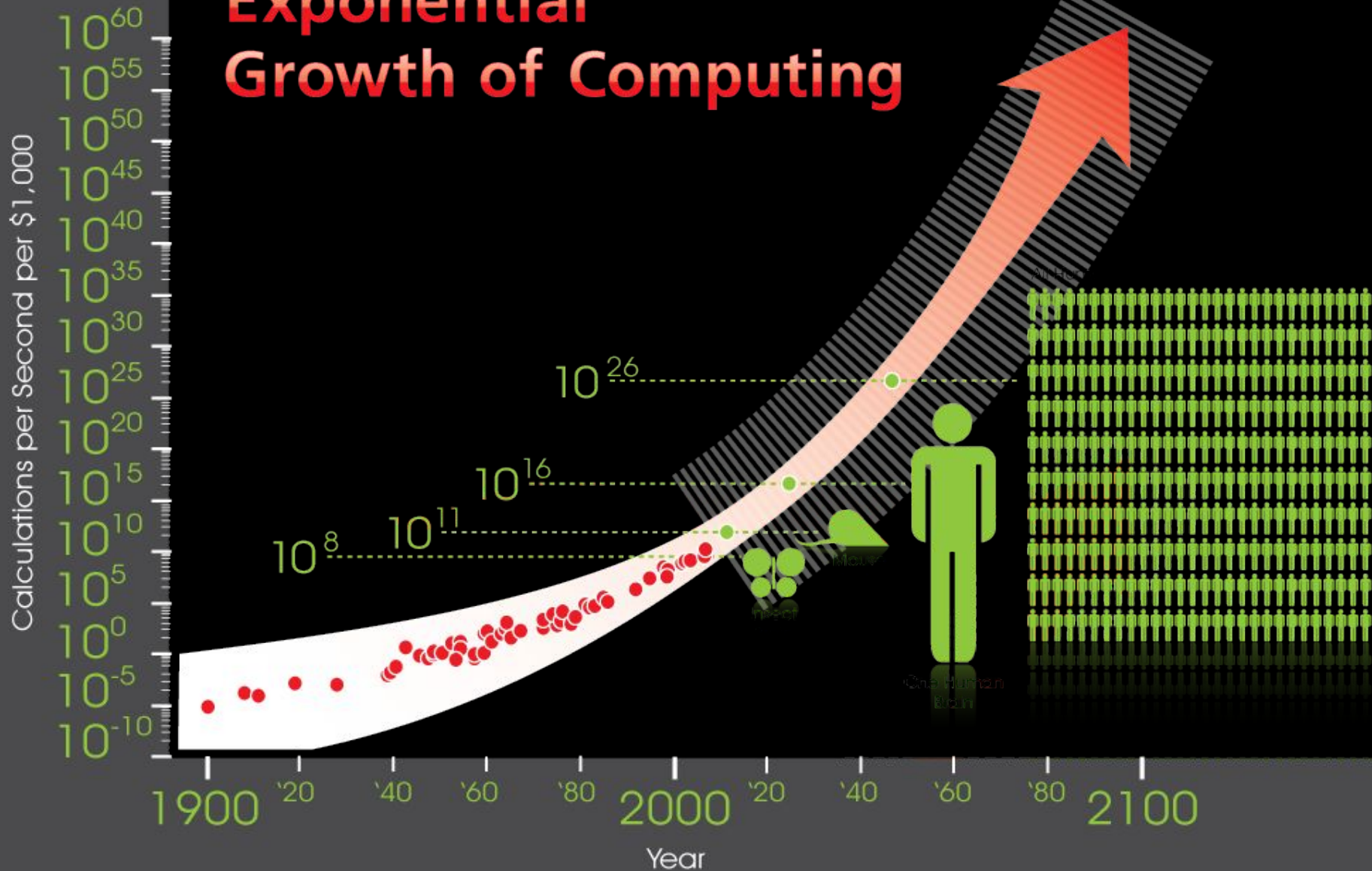
# Exponential Growth of Computing for 110 Years
