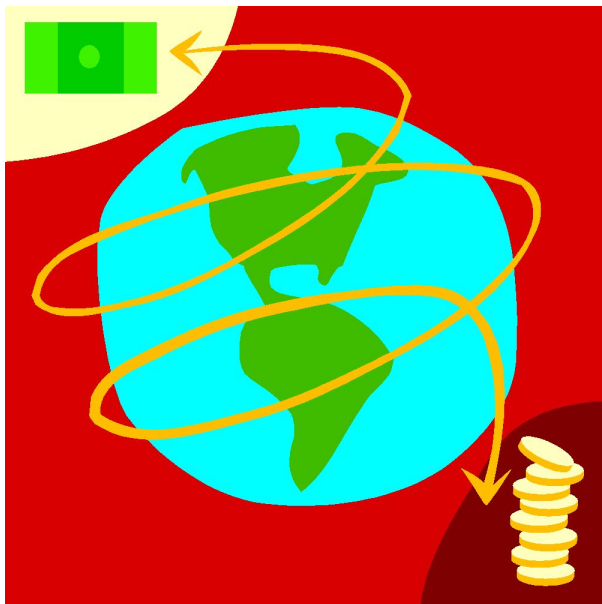
**Late 1980s** - The Company started to offer space risks insurance, credit insurance, different types of civil and professional liability insurance

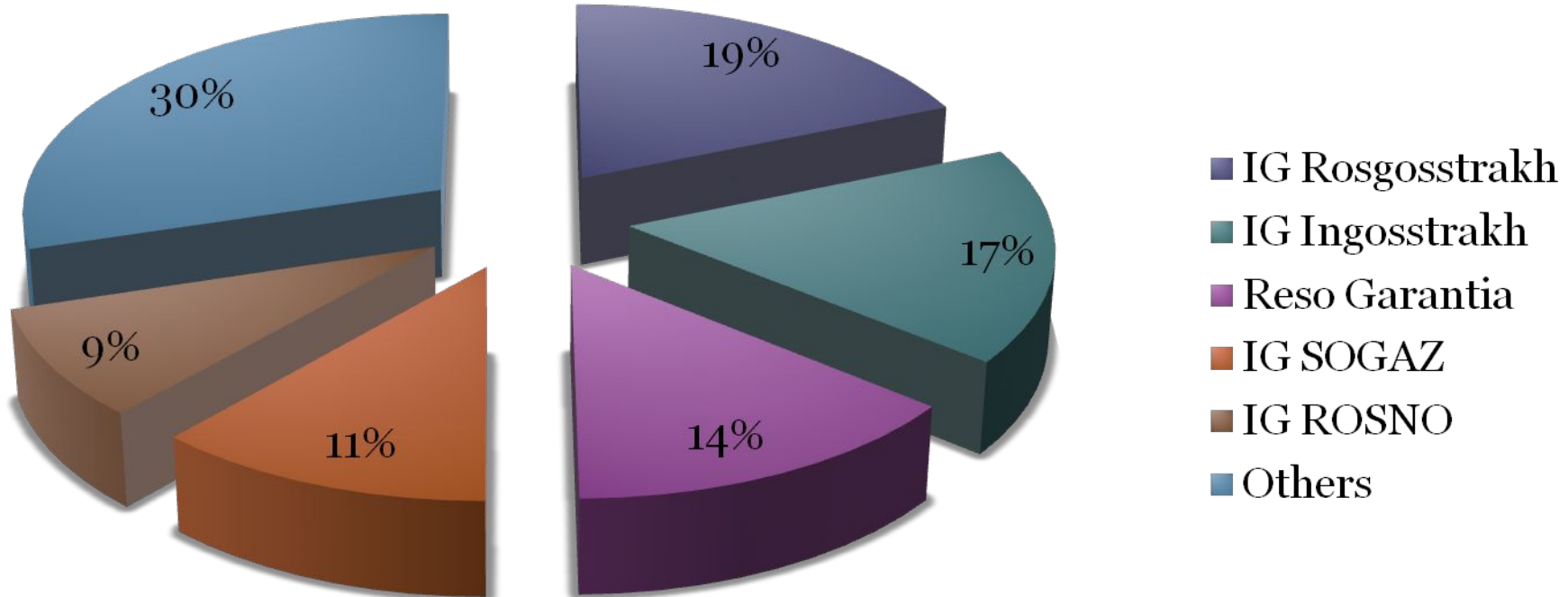

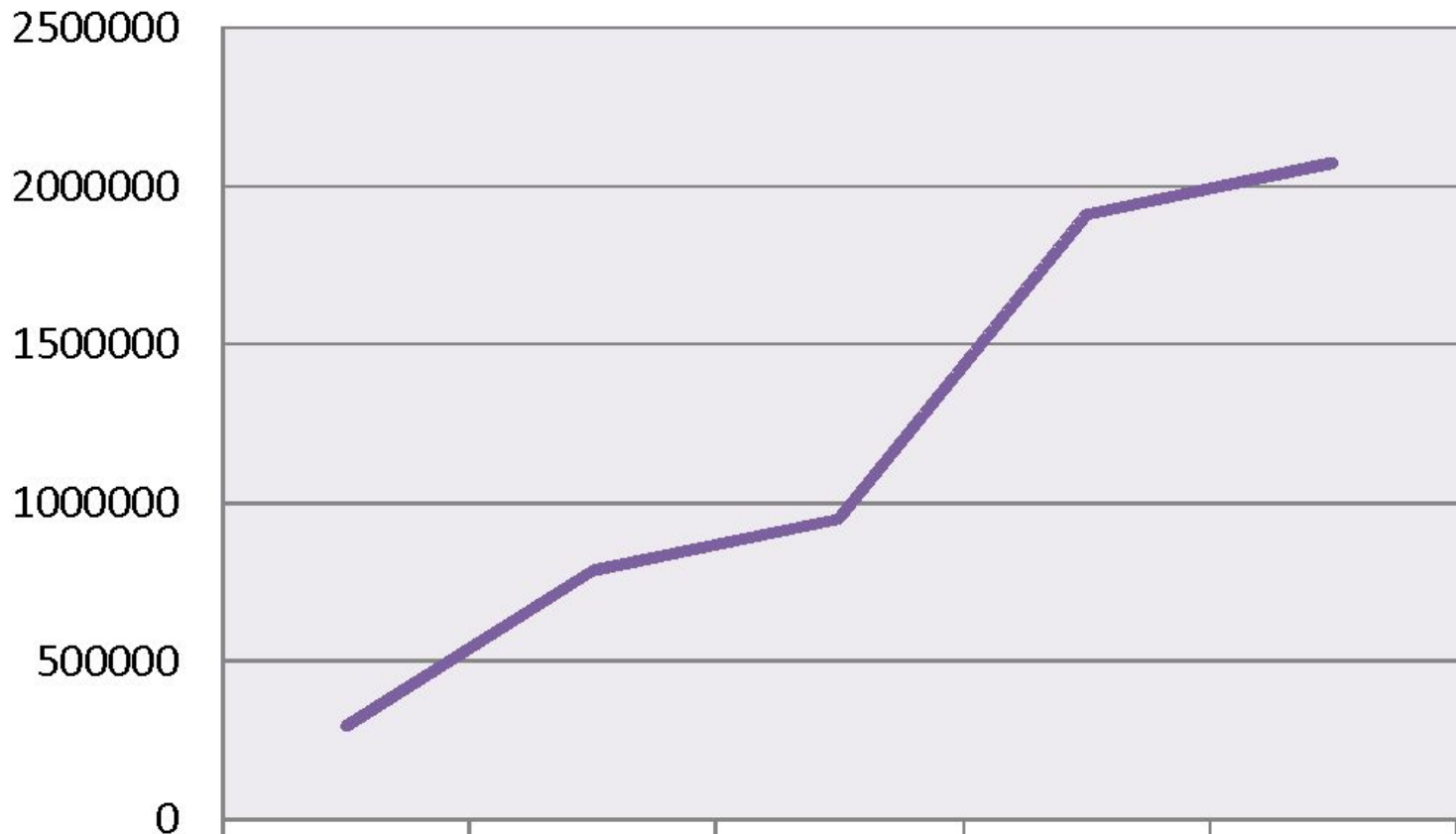

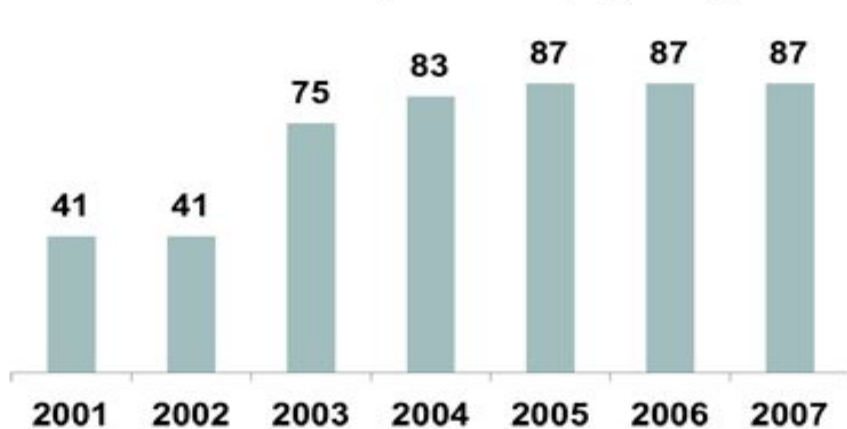
**Net profit, thousands RUB**

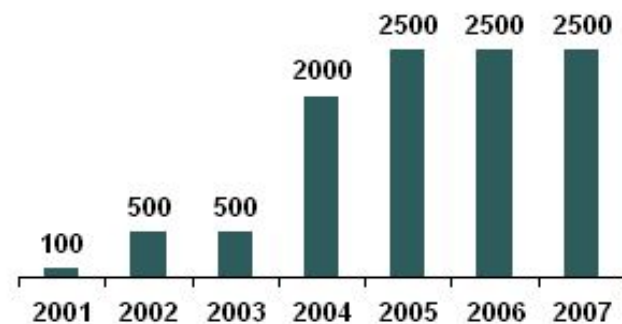
### Количество филиалов, единиц



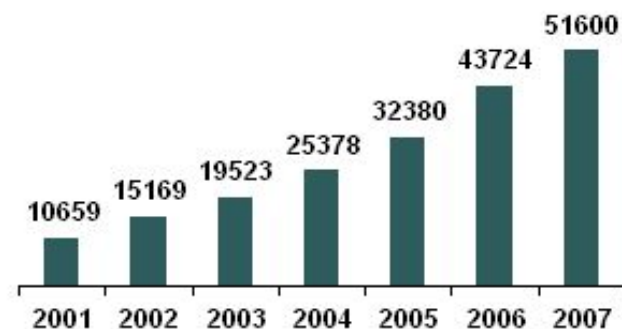

### Уставный капитал, млн. рублей



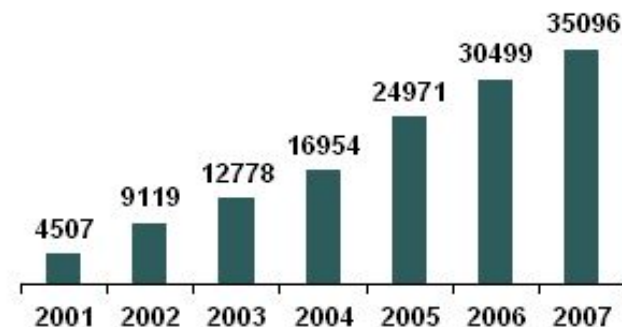
### Активы, млн. рублей

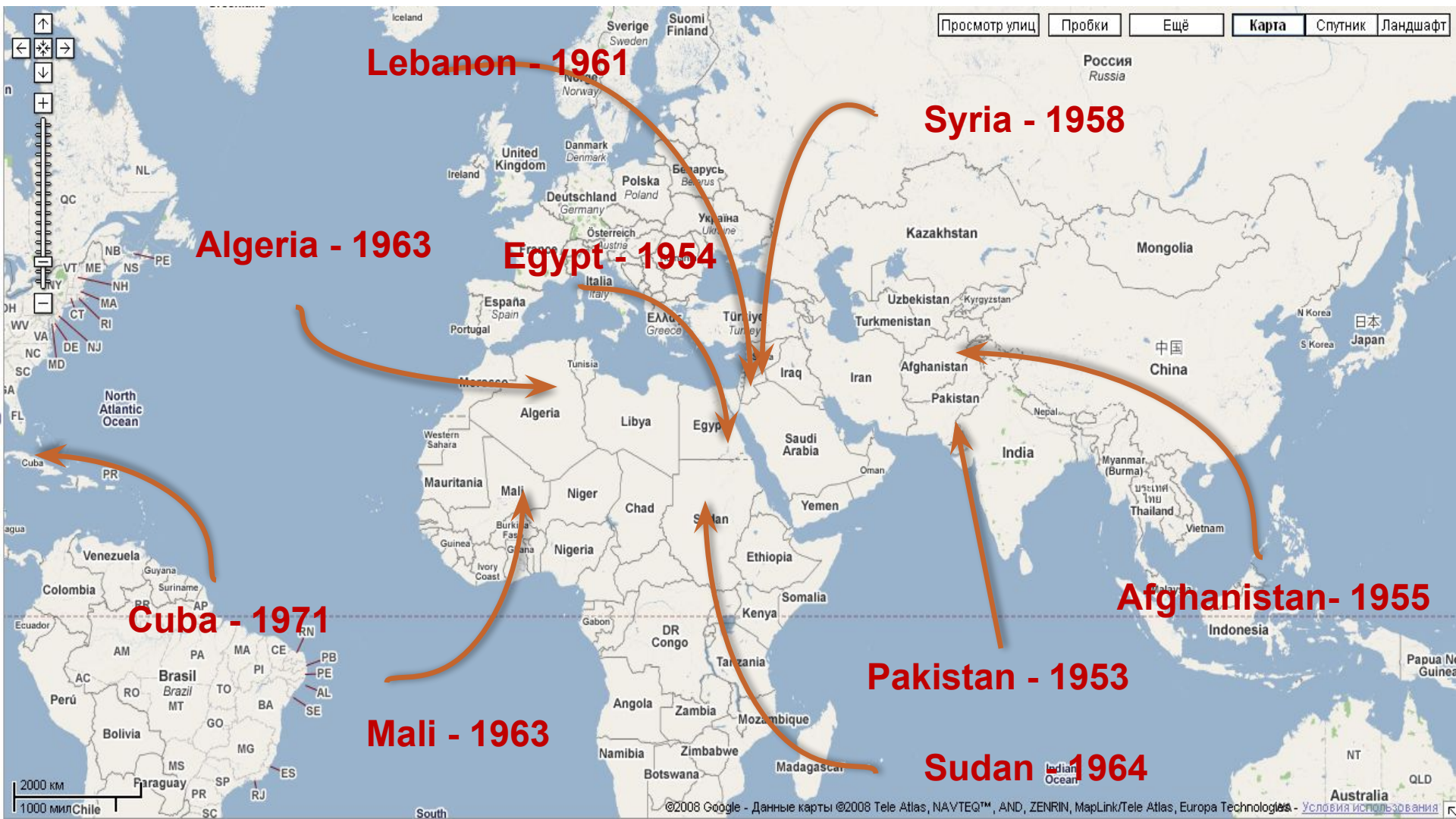
