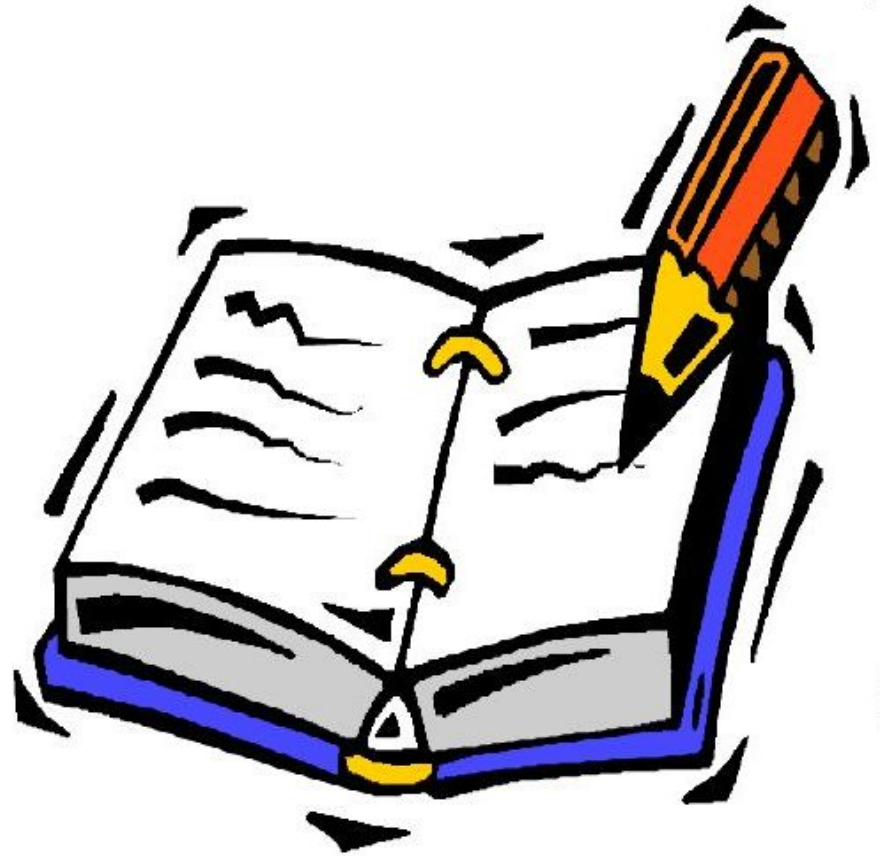

- (3) To be complied with (должны подчиняться) by all people in the country

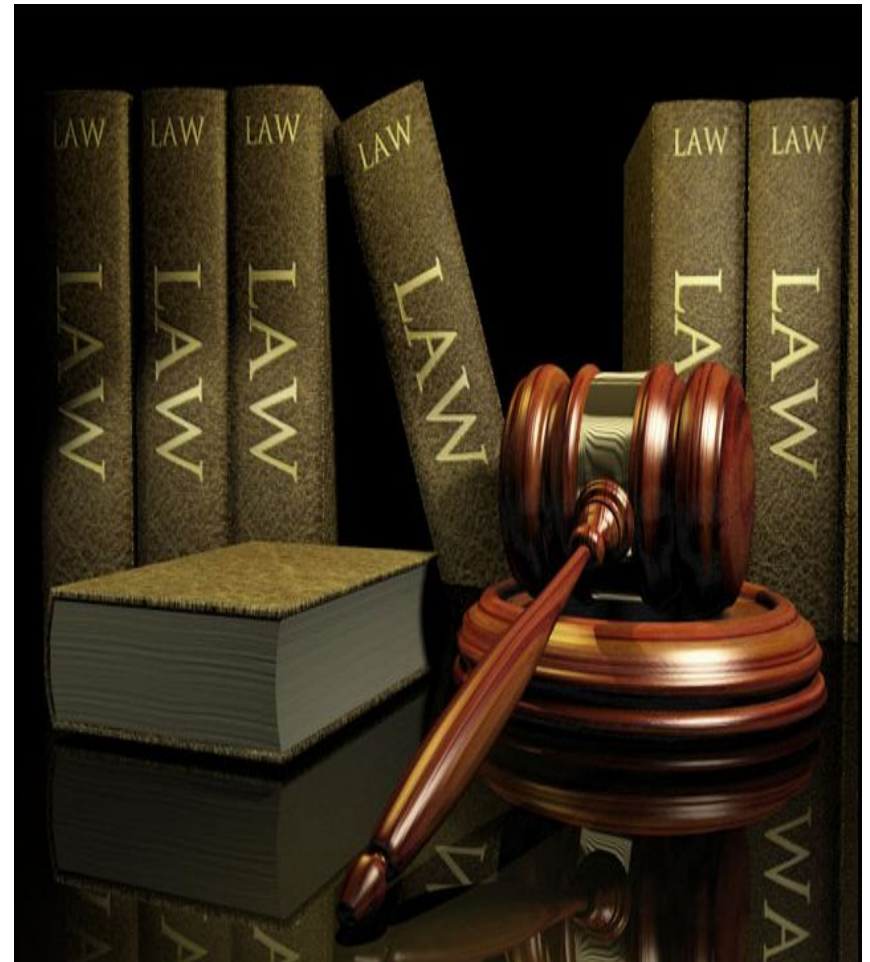
