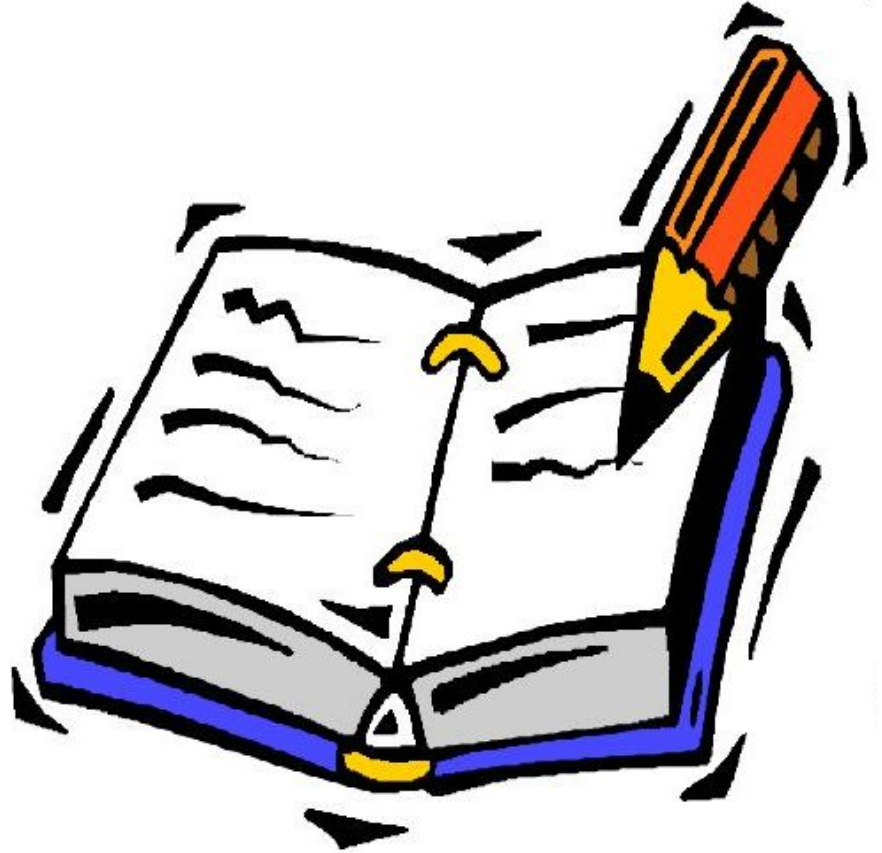

1. Action in Time



Example

In **2009**, **Marina** rented (взяла в аренду) a house for 3 years.

In **2011**, KZ Parliament passes a statute obligating all tenants (арендаторы) **to be registered** with tax authorities within **a month** from the **beginning** of the contract.

In the event of non-compliance (не соблюдения), the penalty is a fine of KZT 10 mln.

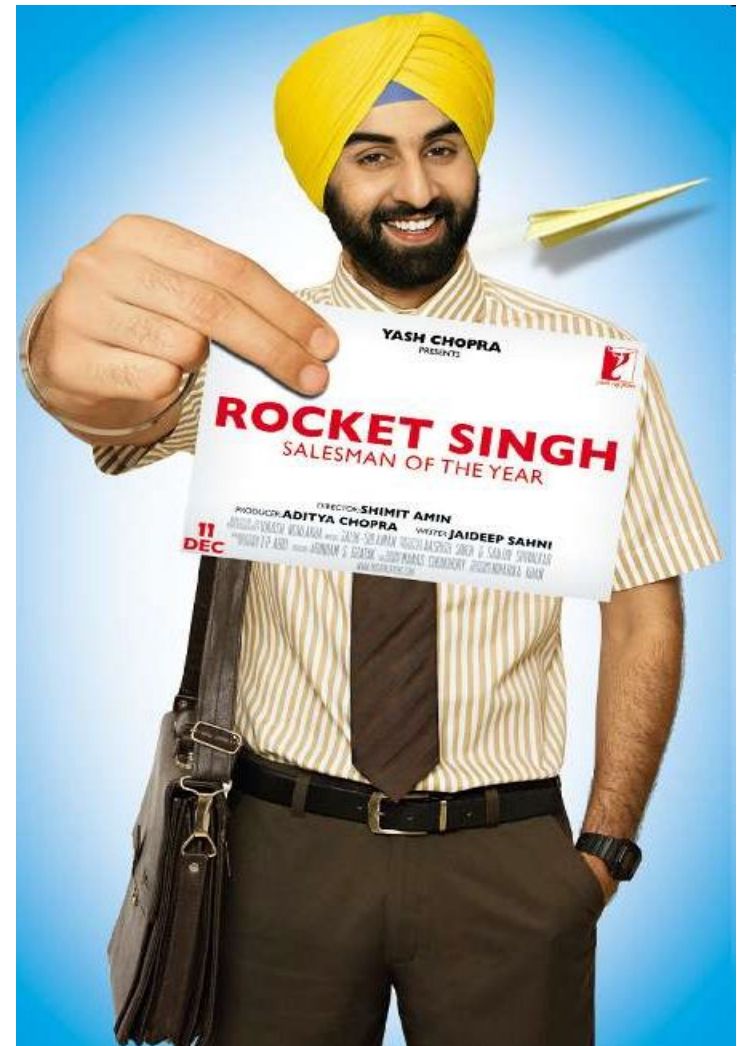

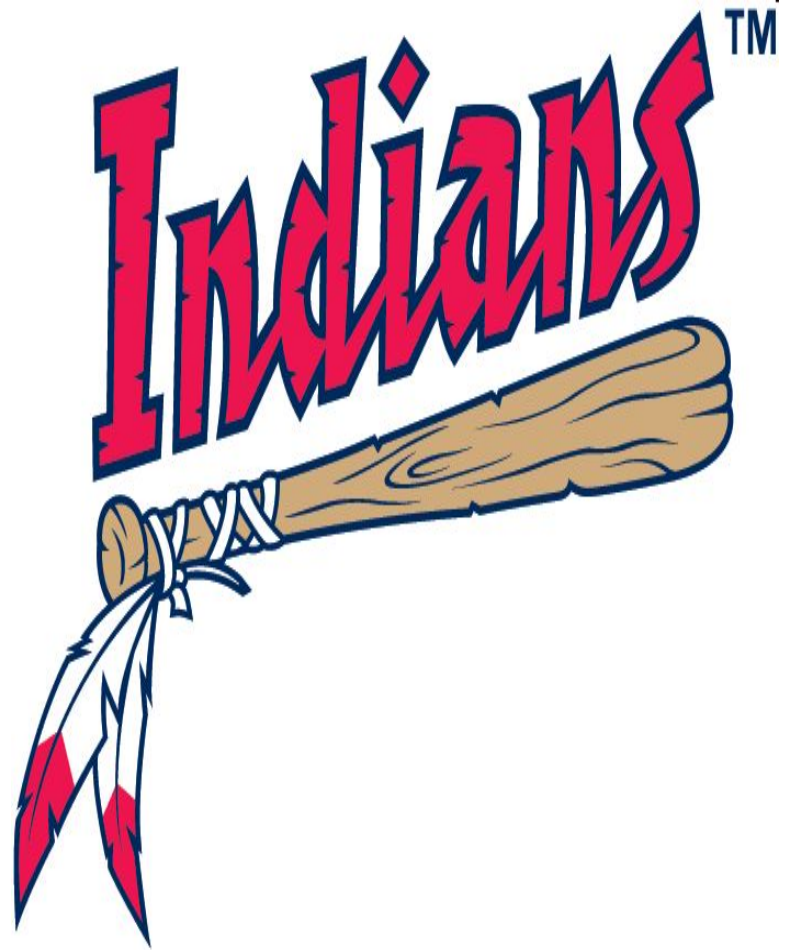
