





technical ones.**

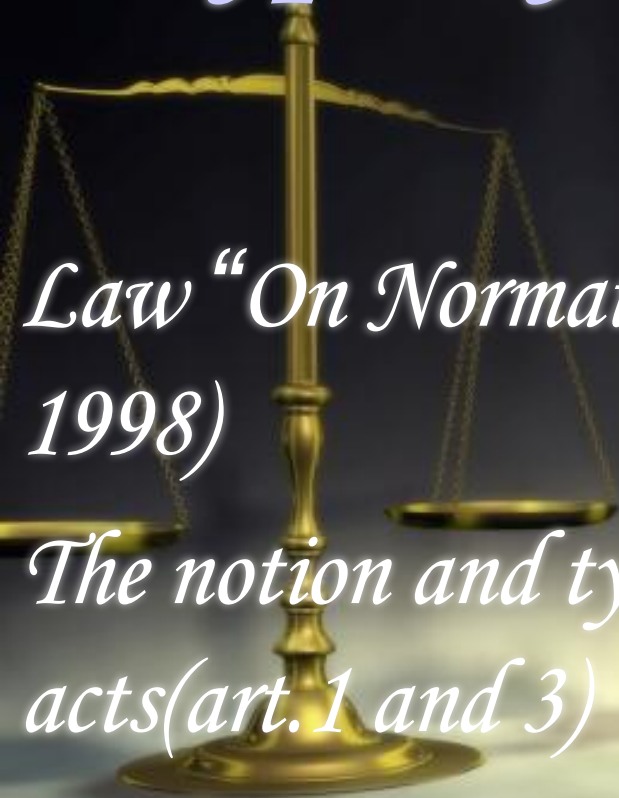

- *has **objective** character*
