Igor Shegolev, the RF Minister for Communication and Mass Media, went online to answer some of 5,000-plus questions by the national audience. Below, we post the translated transcript of some excerpts from his online press-conference that concern primarily the Internet and related issues, which might of be a particular interest to the global Internet community

Question: Is it possible to create in Russia a sole public Internet provider? Is it sensible from the economic perspective?

Igor Shegolev: We are aware that the Internet emerged as a very flexible technological and economic structure, which evolves and updates itself very rapidly. The practice shows this can be best achieved in the conditions of competition. Meanwhile, monopolists at a certain stage are apt to dictate their conditions, increase prices, thus, traveling along the same cycle, we will be back to the already discussed question, that is, the services being provided at a higher price. And this will scare many users off. That is why, it seems to me, this is inappropriate today. There is no need in this.

Q: When will a new Act on the Internet be promulgated?

I.S.: As far as an Act on the Internet is concerned, we need to understand what is going to be its primary subject and how we are going to regulate that. Internet is a strictly cross-border phenomenon that has no analogues. It has recently emerged in the international legal area, too, and it is argued there has been no common attitude towards it as yet. The technology is such that if one tries any punitive, repressive measures in a country, they would hardly be a success, even if we imply assault on obvious offenses. Making such measures against the offences effective necessitates having the international community come to some consensus on the nature of these phenomena that must be countered and which methods one needs to employ to do so. So far the common perspective has been developed to a certain extent, say, with regard to child pornography and cybercrime. Hopefully, in the foreseeable future, there will appear if not broad international agreements but at least recommendations by the bodies that are engaged particularly in regulation of communication networks as to how to counter all this. It is only then that we would contemplate the idea of how to fix such recommendations at the national level....
