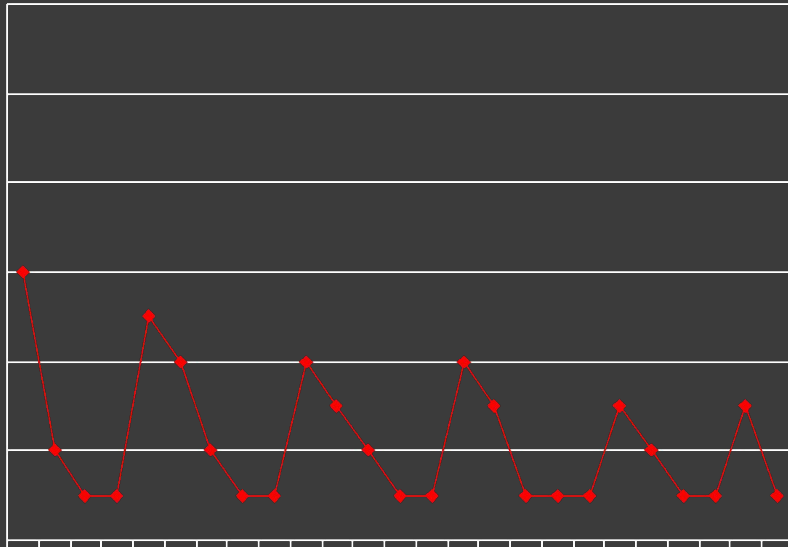
Закон Российской Федерации «Об образовании» от 10 июля 1993 года №3266-1 (статья 32)
