WOMEN IN LEADERSHIP

Women remain underrepresented in leadership and management level positions in the public and private sectors. While quotas have been implemented to boost women's participation in politics and corporate boards, parity is far from reality.

SPOTLIGHT ON

INTIMATE PARTNER VIOLENCE

Intimate partner violence against women and girls is widespread across the globe. In the most extreme cases, it can lead to death. Social norms and widespread impunity for perpetrators are key challenges fueling this type of violence.

1 IN 5 **WOMEN AND GIRLS** aged 15-49, reported experiencing physical and/or sexual violence by an intimate partner within a 12-month period.*

49 **COUNTRIES** have no laws specifically protecting women from domestic violence.

UNPAID CARE & DOMESTIC WORK

Women and girls perform the bulk of unpaid care and domestic work. Combined with paid work, this leaves women and girls working longer hours with less time for rest, self-care, learning, and other activities, such as political participation.

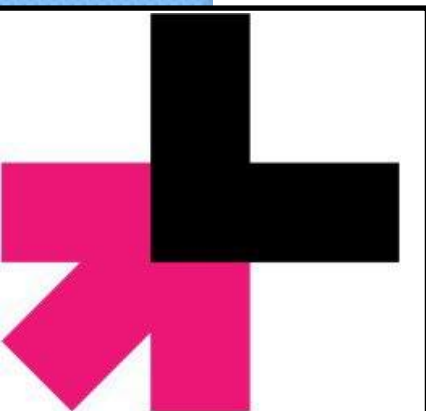
3x On average, women do three times as much unpaid care and domestic work as men.

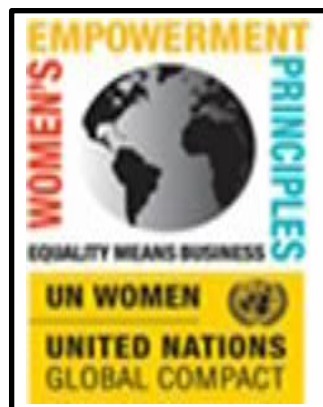

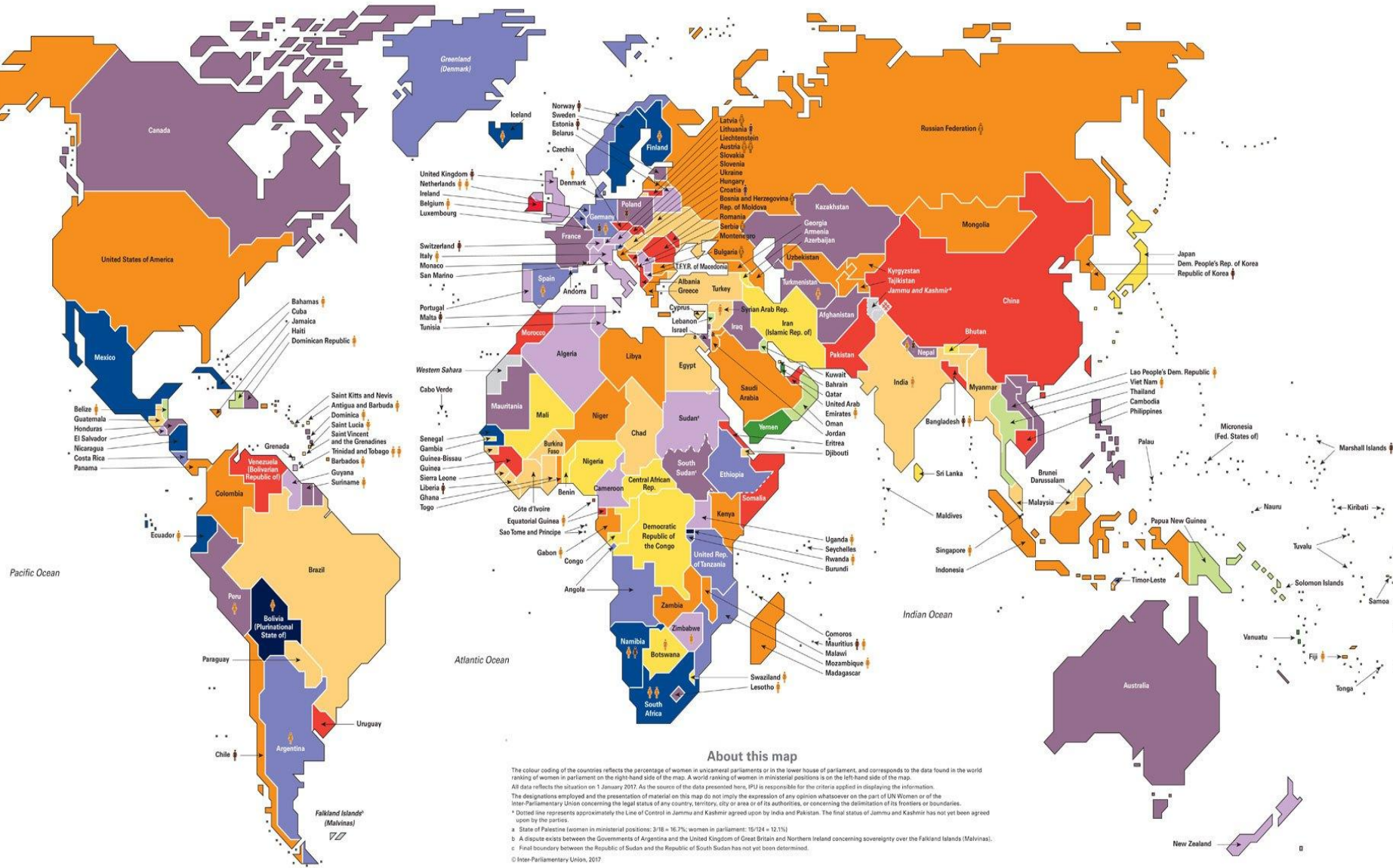

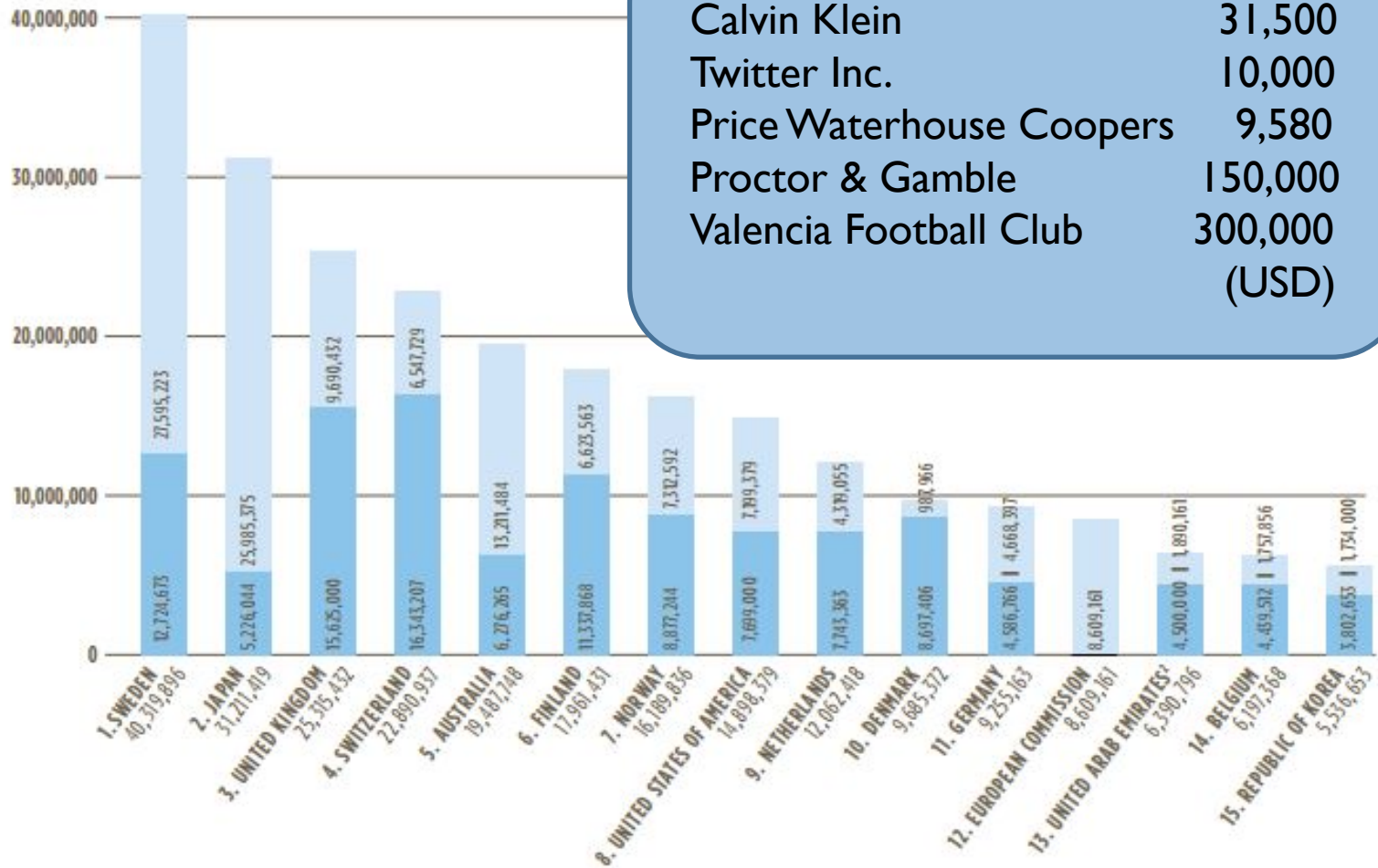
