The ISI mark is a standards-compliance mark for industrial products in India since 1955. The mark certifies that a product conforms to an Indian standard (IS) developed by the Bureau of Indian Standards (BIS), the national standards body of India.

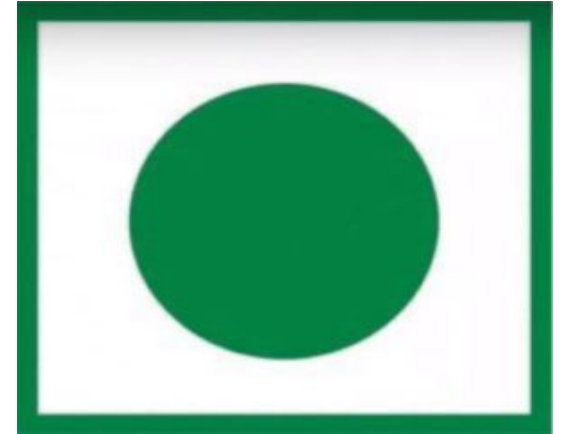
- Product category: Industrial products

# INOFFICIAL SYMBOLS OF FOODS IN INDIA

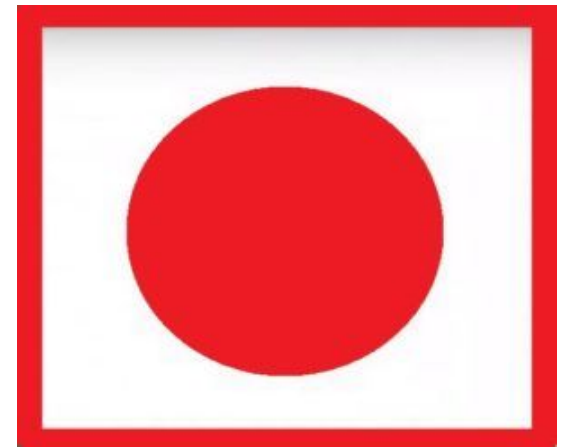
## Veg Logo :

- You may be familiar with this logo. Its a logo with a green circle inside a green square as shown above. This logo signifies that product inside the packet is fully veg. That is, it doesn't consist of any non-vegetarian element/material.



## • Non-Veg Logo :

- Non-Veg logo is similar to Veg logo. The only difference is color. That is, it is of red color as shown above.
- It signifies that the product inside the packet is not for vegetarians. As it consist of non veg elements



# INOFFICIAL SYMBOL OF CURRENCY IN INDIA

- The Indian rupee sign (sign: ₹; code: **INR**) is the currency symbol for the Indian rupee, the official currency of India. Designed by Udaya Kumar, it was presented to the public by the Government of India on 15 July 2010, following its selection through open **competition** among Indian residents.



# INOFFICIAL SYMBOL OF ISRO IN INDIA

- The Indian Space Research Organization (ISRO) is the pioneer space exploration agency of the Government of India, headquartered at Bengaluru. ISRO was formed in 1969 with a vision to develop and harness space technology in national development, while pursuing planetary exploration and space science research.



# INOFFICIAL SYMBOL OF AIR FORCE IN INDIA

- The **Indian Air Force (IAF)** is the air arm of the Indian Armed Forces. Its complement of personnel and aircraft assets ranks fourth amongst the air forces of the world. Its primary mission is to secure Indian airspace and to conduct aerial warfare during armed conflict. After India gained independence from the United Kingdom in 1947, the name Royal Indian Air Force was kept and served in the name of Dominion of India.





# INOFFICIAL HINDU RELIGIOUS ICONIC SYMBOL OF INDIA

- Om, (ॐ) is a sacred sound and a spiritual symbol in Indian religions. It signifies the essence of the ultimate reality, consciousness or Atman. More broadly, it is a syllable that is chanted either independently or before a spiritual recitation in **Hinduism**, Buddhism, and Jainism.



# INOFFICIAL SYMBOL OF RAILWAY IN INDIA

**Indian Railways (IR)** is a governmental entity under the Ministry of Railways that operates India's national railway system. It is run by the government as a public good and manages the third-largest railway network in the world by size, with a route length of 68,155 km (42,350 mi) as of March 2019. 40,576 km (25,213 mi) or 64% of all the broad-gauge routes are electrified with 25 kV 50 Hz AC electric traction as of August 2020
