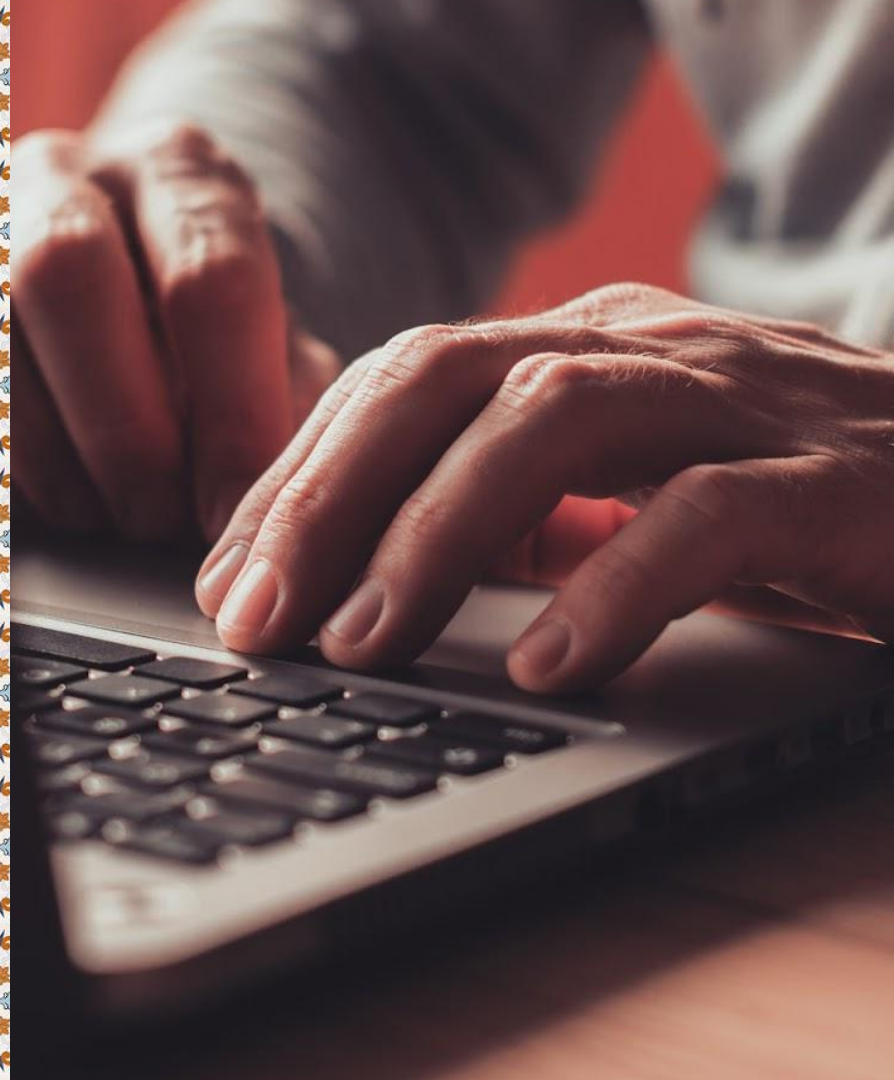

RAPID GROWTH PROBLEMS

The financial infrastructure of EU countries does not keep up with the development of the crypto industry, and users of crypto wallets face the following problems:



A limited number of businesses accepting cryptocurrency



Difficulties with converting cryptocurrencies to fiat and vice versa



Difficulties buying both: cheap and expensive products, using cryptocurrencies



Different limits and restrictions for crypto money users

All these factors are inconvenient to the users, hinder the growth of crypto wallet companies, and slow down the development of the industry as a whole

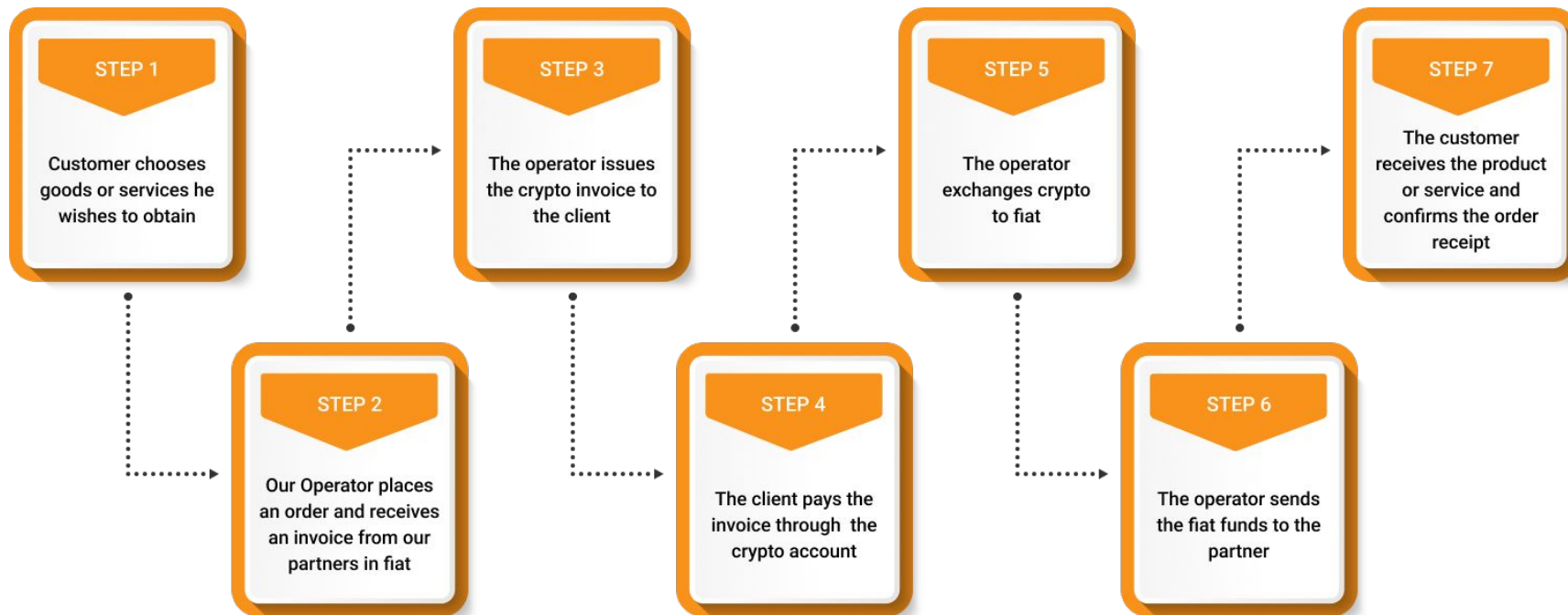
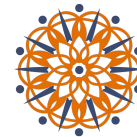
OUR SOLUTION

CONCIERGE-SERVICE FUNCTIONALITY



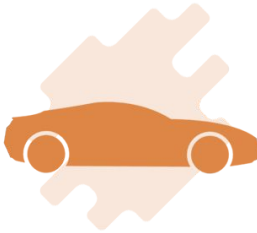
With our concierge service, crypto wallet users will be able to:

TECHNICAL IMPLEMENTATION OF THE PROJECT

The project's website will have its own Instant Messenger (IM) integrated for crypto concierge clients to have direct customer service 24/7 in Portuguese, English, and other required languages.



the online chat platform installed in our partners' crypto wallets will allow our clients to contact us at any time



our company's website provides customers with instant messenger, phone number, and email address to contact us directly



for our customers' convenience; we are also accessible through popular social media platforms such as WhatsApp or Facebook messenger.

Payments and transfers within the framework of the concierge service will be carried out based on our own software developed by our team

- the project will cooperate with charitable organizations and foundations.

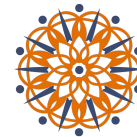


SOURCES OF INCOME FOR THE PROJECT

2. Crypto-concierge service will charge commissions from partners for attracting new customers/clients;
3. The crypto-concierge service will charge fees from users when making transactions during purchases of goods/services.

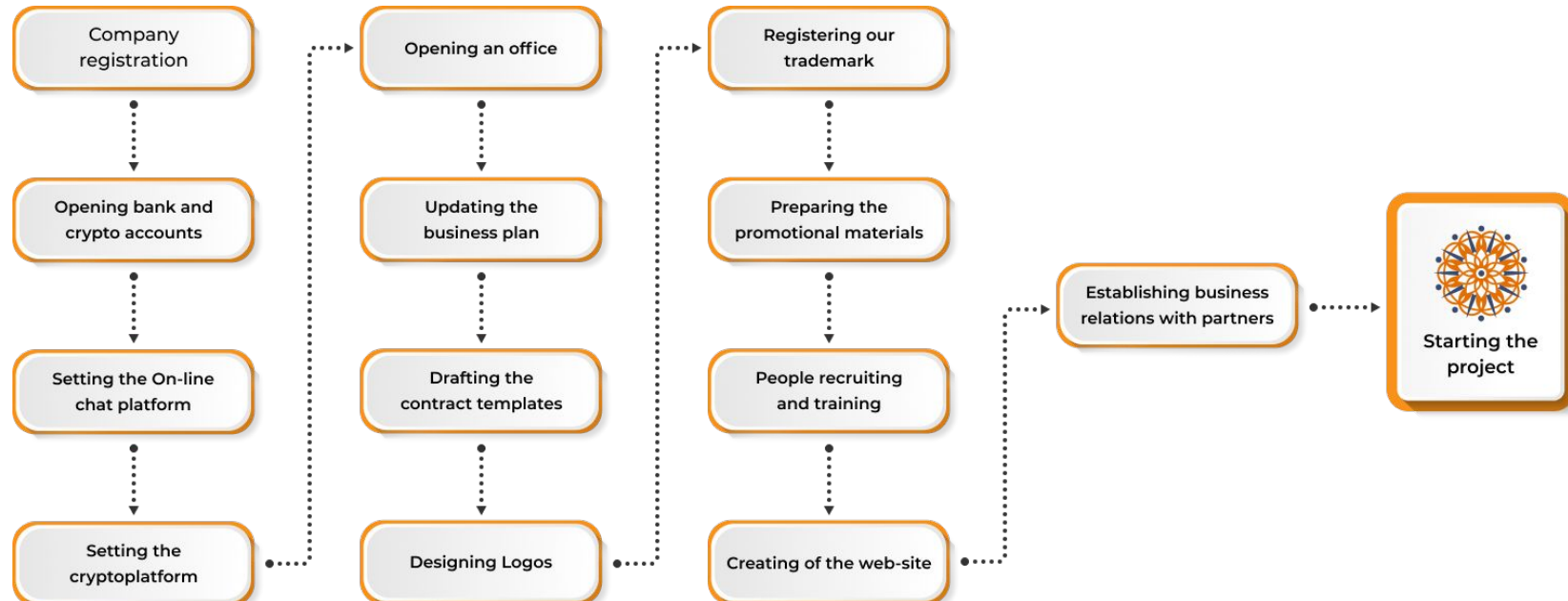

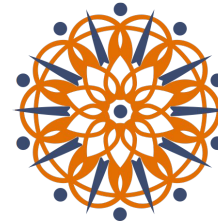
